So please, when you park or have a visitor park, please ensure that their vehicle is parked correctly against the curb (both tires on the gutter) and not in a yellow zone. Taking a little time to go the their car and checking could safe a lot of time traveling out to Advance's lot to pick it up later.

# **SNOW REMOVAL 2003**

This year our area experienced an extraordinary amount of snow, which hopefully, we will not experience again for several years. In spite of the unusual accumulation of snow, Kings Park West Community fared considerably better than most neighborhoods in Fairfax. This was due, in part to the efforts of Advanced Towing who kept our streets plowed throughout the snowfall and our neighbors who worked together to ensure that our streets and sidewalks were safe for everyone living in our community.

Despite the fact that our community was one of the first in Fairfax County to be plowed, the Board of Directors, along with the input of many residents, was able to identify areas for improvement in future snowstorms. We have asked Advanced Towing to use two plows,

starting at each entrance of the community, and make a preliminary "sweep" of the neighborhood in order to give all residents initial access to the roads. In addition, Advanced will try to plow "curb to curb" around common areas and along the street.

In order for the community to gain the maximum benefit from the plowing company and keep the community safe, there are a few things that we as residents of Kings Park West need to do:

- 1. Park in your numbered parking spaces during a snowstorm to minimize the number of cars in the authorized curb parking. This will allow the plows to push the snow further into the common areas and plow "curb to curb", freeing up more street parking and making a wider passageway for vehicles and emergency equipment.
- 2. Shoveling of mailboxes, fire hydrants and storm drains is the responsibility of Kings Park residents and is not included in our snow removal contracts. Please help keep our community safe and assist public servants in doing their jobs by shoveling out the hydrants, storm drains and mailboxes near your home. This is something that not all residents are physically able to assist with, but is a high priority for everyone during storms with a significant snowfall.
- 3. Be courteous of your neighbors and remember that shoveling snow from your sidewalk or parking space into the street or someone else's space may impede your neighbor getting out and could ultimately present a safety hazard for motorists and children or prevent access to emergency vehicles.

Overall, Kings Park West survived the winter of 2003 relatively unscathed. The community pulled together and worked as a team to shovel each other out. Thank you again for your consideration and hard work. This is what makes our neighborhood a great place to live.

# **REMINDERS**

The PWCA Parking Committee would like to remind everyone of the community parking regulations. Cars double-parked or parallel parked not touching the concrete gutter or parked in areas designated with yellow curbs (fire zones) are subject to immediate towing. Also, please be courteous of your neighbor's reserved spaces. Parking in another resident's space without permission is also subject to immediate towing. Finally, if you are having someone to your house YOU are responsible for notifying them of the community parking regulations. If your or your guest's car is towed, please call Advanced Towing (703) 978-7990. If you would like to contest the tow or would like to see the photograph showing the violation, please call the Parking Committee Chair, George Burgee, at (703) 503-0065 between 8:00 A.M. and 9:00 P.M. to schedule an appointment.
